

# INFORMATION FOR CANDIDATES REGARDING VERIFICATION OF KNOWLEDGE OF THE ENGLISH LANGUAGE IN B2 LEVEL FIRST CYCLE /BACHELOR'S/ PROGRAMME

## 1. GENERAL INFORMATION

In case of Foreigners:

- who are not EU citizens within the meaning of article 2 (3) of the act of 14 July 2026 of 14 July 2026 on the entry into the territory of the Republic of Poland, residence in and departure from the territory of citizens of European Union member states and members of their families (Dz. U. of 2024, item 633 and 1688 and of 2025, item 619), **applying for admission to full-time first-cycle programmes or long-cycle programmes** on the basis of a document issued abroad, which is a document confirming eligibility to apply for admission to studies, as referred to in article 326a (1) of the Law on Higher Education and Science **and**
- applying for admission on the basis of a document issued abroad, which is not a document confirming eligibility to apply for admission to studies, as referred to in article 326a (1) of the Law on Higher Education and Science:

**The University verifies the English language knowledge in a specific field and profile of study, at a language proficiency level of not less than B2.**

**The English language knowledge verification is based on:**

1. language exam held by the Krakow University of Economics **or**,
2. certificates confirming language knowledge, in which the studies are conducted, as listed in the decree of the Minister of Higher Education and Science issued on the basis of Article 70 (5f) of the PSWiN Law.

**Note! Those who possess a Card of the Pole, a permanent residence card, EU resident card - it is mandatory to take the English language exam at B2 level.**

## 2. ENGLISH LANGUAGE EXAM

**The exam will be held in remote form in synchronous mode on the Teams platform.**

**July 2nd, 2025 (Wednesday).**

The exam time and detailed information regarding the exam will be provided to registered candidates a few days before the exam.

Only candidates, who sign up for the exam will be able to take part in it!

#### **a) CONTENT OF THE ENGLISH LANGUAGE EXAM**

The English exam consists of several parts. One type of task is a separate page in the test. The types of tasks are: reading comprehension, understanding the meanings of words used in written statements, listening comprehension and lexical grammar test. Almost all the tasks are based on a selection test, except for one listening comprehension task where you will have to complete / enter missing information - single words.
